The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Government Polytechnic Miraj, Near Maji Sainik Vasahat, MIDC Area, Vidyanagar, Miraj-416410, Maharashtra** as a whole.
